The Ceremony of Remembrance and Renewal is a public observance designed as a two part celebration that has been preserved as a solemn service—a ceremony to honor the Knights of Rose Croix who have fallen over the past year. The first part of this commemoration is a gathering to remember our friends, honoring those that have passed by the extinguishing of the lights. This section is symbolic of the crucifixion, reminding us of our mortality. It is recognition of our Brothers who passed over the last year and their lives and earthly labors. The second section is the relighting of the lights, recognition of the resurrection of Christ and signifies our acceptance of life hereafter; it is a celebration of what is yet to come. This custom is a time-honored tradition dating back to 1856. A ritual observed annually by Scottish Rite Masons around the world occurring on or near the vernal equinox. This year's Scottish Rite Ceremony is on Tuesday, March 15, 2016 at the Trinity United Methodist Church in Salina, Kansas.

Message from the Secretary

December 13, 2015 Valley of Salina hosted an open house at our new location, 1416 South Santa Fe, Salina, Ks. In spite of some very nasty weather forty people attended. Members and friends from North East Kansas, Hutchinson, Wichita and Salina enjoyed touring the building. Refreshments were prepared and served by Office Manager Nadine Gable, Bev Hamilton and Carol Winn.

Special guest from Wichita was III: Hugh W. Gill III 33° S.G.I.G., Orient of Kansas.

As you know moving can be challenging, but we met the challenge and are settling in at our new location. The stain glass from the 3rd floor and clock from the lobby of the Masonic Temple were moved under the direction of Kenny Swisher, 32°. The beautiful stained glass was a gift presented to the Scottish Rite by members of the Dedication Class of 1927. Interestingly, the window was never installed. It was left in a shipping crate until the late 1970's. At that time it was removed from storage. Delicately cleaned and prepared for back light display. The glass was crafted in Germany by some very talented artists.

The large Majestic Grand Father clock was a gift presented by New Temple Class of 1924.

Research on the clock and glass was done by the late Scottish Rite Member, Sam Wygal. Kenney's job did not end with moving the stained glass and clock. He also built the frame around the glass, installed the back lights and the wrought iron railing. Carl Winn stained the wood after Kenny got everything else done.

The Order OF THE TEMPLE was presented to Kenny. This is awarded to those who have served Scottish Rite, Valley of Salina, Orient of Kansas, with faithful service, dependable and positive attitude with willingness and gracious consideration of the Rite.

The stain glass that was in the door of the Scottish Rite office is being framed and we will hang it in the meeting room. In 1901 Sovereign Grand Commander James D. Richardson gave a Centennial Address introducing the Scottish Rite Creed. "The case of human progress is our cause, the enfranchisement of human thought our supreme wish, the freedom of human conscience our

mission, and this guarantee of equal rights to all people everywhere, the end of our contention."

The Scottish Creed was changed in 1990. Ill:. D. Walter Jessen stated "It is not to alter the meaning of Scottish Rite philosophy as it relates to the important issues addressed by the Creed.

The new Scottish Rite Creed, "Human progress is our cause, liberty of thought our supreme wish, Freedom of conscience our mission, and the guarantee of equal rights to all people everywhere our ultimate goal." This is from the Amicus Librarium and Joan Kleinknecht is the Librarian. My hope is in God.


