Nationwide, the Scottish Rite of Freemasonry of the Southern Jurisdiction of the United States has implemented a very successful program to help children with speech and language disorders. The Scottish Rite RiteCare® clinics provide diagnostic evaluation and treatment of speech and language disorders, as well as learning disabilities. Today, there are 178 RiteCare® clinics, centers, and special programs operating or planned throughout the United States. Each facility is staffed by speech-language pathologists or other trained personnel. Through the support of Scottish Rite members, tens of thousands of youngsters across the United States have been helped significantly. Facilitating the good work of dedicated clinicians and parents, the Scottish Rite has achieved dramatic successes. Children who might have remained educationally behind for a lifetime can now talk, read, and lead productive lives.

In Kansas, seven Scottish Rite organizations, called Valleys, are organized and coordinate their philanthropic speech, hearing, language, and learning disabilities programs in conjunction with the Speech-Language-Hearing Clinics at KU Medical Center, University of Kansas, Wichita State University, and Ft.

Hays State University. The Ancient and Accepted Scottish Rite of Freemasonry Valleys in Kansas include the: Armed Forces Scottish Rite Bodies, Ft. Leavenworth; Scottish Rite Temple, Ft. Orient of Kansas "Expanding the Footprint of RiteCare

As Deputy, then as Sovereign Grand Inspector General, I assumed the Presidency of the Kansas Scottish Rite Foundation. It was through the Foundation that I became more knowledgeable of our Clinics and personally committed to RiteCare in Kansas. It did not take long for me to realize there was a big gap in the geographical coverage by RiteCare within the State. Essentially three quarters of the state, the entire western half of Kansas and the SE quarter were not served. Rather a backward way of saving RiteCare existed in the NE quadrant only. I hoped that could be corrected and expansion made to include a RiteCare presence throughout the Orient of Kansas.


Part of that goal was accomplished with the assistance of Don Mahrle. Don's involvement with KSHA brought to my attention the

speech and language department at Ft. Hays State University, and their interest in becoming a member of the RiteCare network. Through his efforts, those of Dr. Amy Finch and Marla Staab at Ft. Hays, and I acting as the facilitator between Ft. Hays and the Supreme Council in Washington, D.C., we succeeded in dedicating a new Clinic in 2008.

Along the way, I had noticed Kansas State University and its Speech and Language Department was not represented. I am hopeful that we are on the path to having all of our Kansas Universities' speech, language and hearing departments in RiteCare.

The western half of Kansas, because of the long distances involved, is only lightly represented by Ft. Hays State University. While attending a national RiteCare conference I attended a breakout session in which was presented the work Colorado had been doing to develop a telepractice outreach by RiteCare. That struck me as a viable opportunity for Western Kansas. As you know the Foundation and all our Clinics are now in the initial stages of discussing how we might take advantage of the opportunities afforded by telepractice and how to incorporate telepractice into expanding our ability to reach and treat children.

The remote screening clinics envisioned by Steve Kempf at Ft. Leavenworth and his dedication to bringing the concept to fruition on Post at the Fort was totally unexpected. Steve has nearly done the impossible. Not only working through the blockade of US Army Regulations and wariness, but gaining the support of Debbie Daniels and her clinic in Kansas City



to conduct the screenings. The victory for RiteCare and the children of military families owing entirely to the determination of Steve to see it through to reality.

In my travels throughout the State, visiting Valleys, I came to the realization that beyond the cadre of a few dedicated Scottish Rite Masons, our own membership had little knowledge of RiteCare. An awareness by the public at-large of RiteCare was even less. I felt that needed to be remedied. Our Scottish Rite membership and the public needed to be told about RiteCare and understand what it was doing. I kept thinking RiteCare could be much more if we all worked together for the common good. What I had thought was nearly beyond the realm of possibility, became

possible through the synergistic impact of this newsletter. Together, our shared accomplishments will provide greater understanding. I'm convinced we have only begun on the road to a greater RiteCare in Kansas.

Ill Hugh W. Gill, III, was an Air force Pilot and aicraft Commander serving a tour in Viet Nam. He earned a B.A. in Accounting and an MBA in Finance from Wichita State University. FT. LEAVENWORTH SCOTTISH RITE MASONS HAVE DONATED A TOTAL OF **\$7500** TO FUND DIAGNOSTIC AUTISM CLINICS

In March 2013, Scottish Rite Masons from the Fort Leavenworth Masonic Lodge donated another \$1500 to fund a KU Medical Center diagnostic outreach clinic for Fort Leavenworth children and raised the total they have donated in support of this critical program for military children to \$7500.

The Armed Forces Scottish Rite Bodies at Fort Leaven-

worth (Armed Forces **Consistory**) provide support and funding for KUMC Outreach clinics at Fort Leavenworth. The KUMC **Hearing and Speech** Clinic is part of a multidisciplinary task force currently conducting Autistic and learning difficulty diagnostic clinics for children at Fort Leavenworth as part of the KUMED **Center for Childhood** Assessment. They han-

dle two groups of children - from birth to 3 years and 3 years and older - <u>and a diagnosis is provided the same</u> <u>day</u>. This allows the children to get into therapy programs quickly—particularly important to transient military families such as Command and General Staff course student families who are at Fort Leavenworth for only 10 months. It normally takes from 4 to 9 months to get children into the regular diagnostic clinics. It is very important to begin Autism therapy at the earliest possible age. Once diagnosed, some of the therapy programs are handled by KUMC and Tricare and some by Special Education programs through the school districts.

The outreach clinics are funded by a grant from the <u>Chil-</u> <u>dren and Youth with Special Health Care Needs</u> program of the <u>Center for Child Health and Development</u> at the



University of Kansas Hospital and because of costs they conduct about 6-7 across the state each year with two at Fort Leavenworth. Previously, the Armed Forces Consistory has donated funds for additional clinics, the latest two being on 14 December, 2012 and 29 April, 2013 for the Fort Leavenworth children as the clinic group said they could only take 6 children per clinic. The one day did not give them enough time for more. The clinical outreach team is headed by Dr. Chet Johnson who is also the Chair of the department of Pediatrics. He is a neurodevelopmental pediatrician. He is accompanied by Dr. Debbie Daniels, the Director of the Hearing and Speech Center and other speech therapists and child psychiatrists. The clinics are conducted in the Pioneer Chapel. An alternative location is the Armed Forces Insurance building on post or the Masonic Lodge (Boughton Hall) on post.

Fort Leavenworth Funding to KU Med Center for Diagnostic Outreach Clinics



Fort Leavenworth Scottish Rite Masons provide needed support to the KU Hospital Diagnostic Outreach Clinic for Autistic and Learning Difficulties. The KU Hospital conducts two clinics each year for Fort Leavenworth children.

The KU hospital funds two clinics each year with their limited grant money. To augment these, the Armed Force Scottish Rite Bodies at Fort Leavenworth (Armed Forces Consistory) has donated funds for three additional KU clinics annually. In the conduct of these clinics, members of the Consistory brought lunch to the members of the KU Team and assisting them as needed.



A Distinguished Military Graduate of the Army ROTC program at the University of Kentucky in Lexington, Tom Dials was commissioned Second Lieutenant, Armor, Regular Army, in 1970. Topeka Valley RiteCare Program

Our Pediatric Audiology Clinic is progressing well. It is being staffed by Dr. Angie Reader of Schiefelbusch Clinic 2 days per month. It will take some time to educate all our area hospitals and pediatricians about the diagnostic services we can provide.

Several meetings have been held with Elizabeth (Liz) Abby, State Audiologist, on how to develop the most effective educational program to accomplish these goals. The Schiefelbusch Clinic recently added an Audioscan Verifier so we can have a complete verification of prescribed hearing aids on our clients.

The Sound Beginnings Board of State Audiologists has conducted two Board Meetings (April and July) at our Conference facilities.

Dr. Jane Wegner and her staff at Schiefelbusch Clinic, along with the Trustees of the Scottish Rite, have held several meetings concerning the development of an early Intervention Speech/ Language Program. The need became very apparent after testing our newborn clients that an early Intervention Program would have a greater impact in the future and continued development of these special clients.

Topeka Scottish Rite has begun working toward a long term approach on raising future funds through gifts, wills, bequeaths, and endowment grants. Meetings have been held with the Kansas University Endowment Department on common goals and ideas.

Our 2013 RiteCare Golf Tournament was very successful with the addition of several new golfers which will help to increase our number of players even more for next year's tournament, which is scheduled for August 8, 2014. For many years we have sponsored a speaker for KHSA's annual meeting. Dr. Jane Wegner and Stephanie Meadow "A Story of Inclusion" was our 2013 Program. It has always been our pleasure to work and support KHSA; as we share so many common goals on children's communication disorders

- Course # 2 Beacons of Best Practice: Sound Articulation Treatment, presented by Jennifer Taps, M.S. San Diego School District conducted on June 5-6, 2013. This course was attended by 62 practicing professionals, students, and faculty.

These courses reached a total of 136 participants who received course material on which were printed the RiteCare logo. Additionally, Dr. Brandel, Chair of the Department, publicly acknowledged the support from the Foundation and spoke about our "RiteCare Clinic" at the beginning of each course.
